7 Day Playing	A 7 Day member is a person who has paid the appropriate fee and is entitled to full member discounted green fees and use of the golf course on any day of the week, subject to availability.
5 Day Playing	A 5 Day member is a person who has paid the appropriate fee and is entitled to full member discounted green fees and use of the golf course from Monday to Friday inclusive, subject to availability.
Country	A Country member is entitled to full member discounted green fees and usage of the golf course subject to availability. They must reside 75km outside Hawks Nest as the crow flies or be a full playing member of another Newcastle District affiliated Golf Club. They are limited to 26 Competition Games per annum.
Intermediate I & II and Junior	Intermediate and Junior members are entitled to full member discounted green fees and usage of the golf course on any day of the week, subject to availability.
Social Golfing	Social Golfing memberships are entitled to a reduced green fee rate. This membership is for social golf only and members are not eligible to participate in competition rounds.
Social	A Social membership entitles members to discounts in the clubhouse for food and beverages. This excludes golfing privileges or discounted green fees.
